Quality and implementation of the research, theory, and argument (as applicable); 4. Analysis and interpretation of the findings (if applicable); 5. Clarity and organization of the writing. Postdoctoral Research Associate: *Social Acceptability, Sustainability and Policy Issues in Developing Perennial Biomass Energy Value Chains*

The Pennsylvania State University's Department of Agricultural Economics, Sociology and Education is seeking a Postdoctoral Research Associate to work on social acceptability, sustainability and policy issues associated with developing perennial crop-based biomass energy value chains in the Northeast United States. The position contributes to ongoing research being conducted by the "Human Systems Team" within a large five-year interdisciplinary USDA-funded project, the Northeast Woody/Warm-season Biomass

Consortium (NEWBio, <u>http://www.newbio.psu.edu/default.asp</u>), led by the Penn State Institutes for Energy and the Environment (<u>http://www.psiee.psu.edu/</u>). Researchers on the NEW-Bio Human Systems team at Penn State University and the SUNY College of Environmental Sciences and Forestry have been investigating social dimensions of current and planned regional transitions to perennial crop-based biomass energy, focusing on case study sites in Pennsylvania and New York. Potential new case studies may include the Chesapeake Bay Watershed, where water quality benefits of perennial bioenergy crops could offer a new economic driver linking sustainable agriculture and renewable energy, and West Virginia abandoned minelands, where technological succession to sustainable energy sources engages models of habitat and landscape restoration.

Responsibilities for the Postdoctoral Scholar include 1) designing, conducting and analyzing new qualitative research (e.g., interviews, focus groups, document analysis) to understand landowner and other stakeholder groups' perceptions, interests, concerns and practices; 2) contributing to implementation and analysis of ongoing project survey research; 3) supporting management, coordination and communication among members of the Human Systems Team and within the larger NEWBio project; and 4) preparing project reports and manuscripts for peer-reviewed publications and making academic and public presentations.

Applicants must have a PhD in Rural Sociology, Sociology, Geography or a related social science discipline completed by the start date. Experience in qualitative research methods (including interviews and focus groups) is required, as is experience in the design, management and statistical analysis of quantitative social surveys. The ability to work both independently and in collaboration with others on a multi-disciplinary, multi-institution research team is crucial. Excellent organizational, writing and oral communication skills are required. Applicants should have demonstrated academic interests related to one or more of the following: social and political dimensions of land use change; biomass or renewable energy development; energy and/or sustainability transitions; environmental/natural resource sociology; political ecology; sociology of agriculture.
